Jump rounds will follow CT rounds of the same fence height

Directions: From GA 400: Exit 11 then turn WEST onto Windward Pkwy, Windward will change names to Hopewell Rd. Follow Hopewell Rd to Birmingham Rd. Take Birmingham Rd to second 4 way stop and turn LEFT onto Birmingham Hwy, go south approximately 1 mile. Our LONG drive way will be on the RIGHT and you will see two large fields to drive between.
